

CVF COVID-19 WAIVER AND RELEASE

The undersigned understands and agrees that before you enter the Chagrin Valley Farms you must complete this CVF Covid-19 Waiver and Release. It is the intention of CVF, LLC dba. Chagrin Valley Farms ("CVF"), that it, its employees, contractors and patrons comply with the CDC COVID-19 guidelines and all orders of the federal, state and local governments in an effort to maintain good health of its employees, contractors, patrons and horses or other animals that are boarded at CVF. Therefore, before you may have access to any building, contact with any employee, contractor of CVF, or any horse or other animal boarded at CVF, you must complete this form, which shall be reviewed by CVF. ***Until you have completed this COVID-19 Waiver and Release, you may not participate in any CVF event, enter or have access to any building or horse located at CVF.***

____ To my knowledge I have not been in contact with anyone diagnosed with or having the symptoms associated with COVID-19, including without limitation fever, shortness of breath, and/or headache.

____ I have not been diagnosed with and do not have symptoms associated with Covid-19.

____ I had Covid-19, have recovered, and it has been at least 30 days since my recovery.

____ I have Read and Understand the ***CVF Horse Show Stay Safe Protocol*** (found on page 2 of this waiver).

The CDC COVID-19 Guidelines requires the physical distancing of 6 feet between individuals, wearing a face mask in public spaces, and regular washing of hands. I agree to comply with the CDC COVID-19 guidelines and all orders of the federal, state, and local governments.

I understand and agree that CVF may establish COVID-19 rules, from time to time and may modify its COVID-19 rules without prior notice. CVF, may in its sole discretion, for the safety of all patrons, its employees, contractors, and horses, prohibit or otherwise restrict my access to its buildings, property, employees, contractors and /or horses or other animals. I agree to comply with the instruction and decisions of CVF. Prohibition of access will not abate any costs charged by CVF.

I understand and agree that I am assuming all risk with regard to my health including contracting COVID-19 by coming onto the CVF property, accessing its buildings, coming in contact with any patrons, employees or contractors of CVF and any of the horses or other animals that are located at the CVF property.

I waive, release and forever discharge CVF, its managers, members, officers, employees contractors, successors and assigns from any and all actions, claims, causes of action, demands liability suit, and expense including without limitation attorneys' fees that may arise or are associated with or result from either my, or any of my family members or any third party contracting COVID-19. I agree not to sue CVF as a result of either me, any of my family members or any third party contracting COVID-19.

I expressly agree to indemnify and hold CVF, and its managers, members, officers, employees contractors, successors and assigns harmless against any and all claims, demands, damages, rights of action, or causes of action, of any person or entity, that may arise from injuries or damages sustained by me as a direct or proximate result of my participation in CVF activities or on CVF property.

CVF Horse Show Stay Safe Protocol

- Employees will wear masks and/or face shields, or plexiglass will be installed where necessary.
- Pre-entries are strongly recommended. Exhibitor numbers will be delivered to individual trainer's stabling areas.
- New additional releases will need to be signed by all participants.
- Only one person will be permitted in the show office at a time, with limited face-to-face contact through plexiglass.
- Disinfectant will be provided at each schooling jump in the schooling area and at the in gate of the showing arenas.
- One non-equine professional per exhibitor is permitted to attend the event
- There will be no gathering of spectators.
- Each exhibitor and their guest (1) should limit their presence at the horse show to their schooling and showing time. Loitering is not recommended or permitted. This includes stabling areas.
- We encourage everyone attending the horse show to wear a mask or shield.
- Signs will be posted to remind everyone about social distancing of a minimum of six feet.
- In the event of a storm you will be asked to shelter in your car.
- No congregating at any time or anywhere on the grounds.
- All awards will be made available at or near the show office.
- Show stabling will be separated by farm.
- Trainers will be held responsible for their barns, ensuring compliance with all rules & regulations.
- Grooming/tacking is to be done in the horse's stall or a grooming stall, not in the aisles.
- Assigned schooling times will be posted & must be followed.
- There may be a posted order of go.
- Anyone exhibiting symptoms of illness are not permitted to attend the show.
- Any individual not in compliance with these regulations will be asked to leave the grounds & not return.
- Concessions will not be available
- **Management reserves the right to change any rules or protocol at any time deemed necessary.**
